# **Utah Jump\$tart Coalition Scholarship Program Rules**

#### **Award**

Up to six (6) \$1,250 scholarships.

# **Scholarship Use**

The scholarship may be used for any field of study at an accredited Title IV fund-dispersing post-secondary institution. <u>Search here</u> for eligible post-secondary institutions. Please direct questions about eligible institutions to Anna Tibbitts at <u>info@utahjumpstart.org</u>.

# Eligibility

#### **Applicant MUST:**

- 1. Be a high school student, graduating class of 2017, at an accredited Utah school.
- 2. Have successfully completed or currently be enrolled in the General Financial Literacy course.
- 3. Show proof that you plan to pursue post-secondary education.

## **Application requirements:**

- 1. Complete online submission form located at <a href="https://www.utahjumpstart.org">www.utahjumpstart.org</a> between January 2, 2017 and March 17, 2017.
- 2. Submit required video as specified in application criteria (attached page 3, Item #2 Video).
- 3. Submit post-secondary institution acceptance letter **OR** document indicating student has completed the application process and is being considered for admission.
- 4. Submit all the above NO later than 6:00 PM on March 17, 2017.

Submission form will be removed from the Utah Jump\$tart website promptly at 6:00 PM on March 17, 2017.

Note: Late, incomplete, mailed or hand-delivered entries will not be accepted.

# **Selection and Judging**

All qualifying entries will be judged by a panel composed of representatives from the scholarship sponsoring organizations. All decisions of the judges are final.

# **Deadline**

All applications must be submitted via online submission form at <a href="www.utahjumpstart.org">www.utahjumpstart.org</a>, and in proper format by 6:00 PM on March 17, 2017. Submission form will be removed from the Utah Jump\$tart website promptly at 6:00 PM on March 17, 2017. \*\*Note: Late, incomplete, mailed or hand-delivered entries will NOT be accepted.



# **Utah Jump\$tart Coalition Scholarship Submission Process**

### 1. Scholarship Application Form

Complete the scholarship application form on the Utah Jump\$tart website, www.utahjumpstart.org.

# 2. College Application

For students to maximize their opportunities, recipients of this scholarship must apply for admission to any accredited Title IV fund-dispersing post-secondary institution. <u>Search here</u> for eligible post-secondary institutions.

#### 3. Video Rules

Submit a 1 to 2 minute YouTube video addressing the following topic:

# "How do you plan to pay for college while keeping your debt to a minimum?"

Students will receive points based on their content and creativity and must meet following requirements:

- 1. Video must be in English.
- 2. Video must be no more than 120 seconds in length. *Videos longer than 120 seconds in length will be excluded from the contest.*
- 3. Video must be the entrant's original work and not infringe on any copyrights or trademarks.
- 5. Video must not contain violent, obscene, immoral, defamatory, derogatory, offensive, illegal or sexually suggestive content.
- 6. Video must not contain, include, or encourage images or activities that are dangerous, unsafe, or present unreasonable risk of harm to a person or property.
- 7. Include at the end of the video at least 3 reference sources (i.e.: books, articles, websites, etc.).

8. YouTube Video title must begin with **UtahJumpstart2017Scholarship**.



# 4. Application Submission

All entries MUST:

- 1. Be in YouTube format and the link must be entered in the online submission form located at <a href="https://www.utahjumpstart.org">www.utahjumpstart.org</a> in the box designated Link for YouTube Video.

- 3. Be submitted by the deadline: **6:00 PM March 17, 2017** Submission form will be removed from the Utah Jump\$tart website promptly at 6:00 PM on March 17, 2017.

#### 5. Winner Notification

Only the 6 winners will be notified directly within the first two weeks of April, and will be announced via various media.

# 6. Scholarship Disbursement

Requests for scholarship fund deferment must be in writing. The Utah Jump\$tart Coalition reserves the right to determine under what circumstances the scholarships may be deferred. All scholarships must be disbursed before May 2020 or be forfeited.
